- I. Other Business
  - a. Paul advised he hasn't received information from any HETCB institution to support an increase in per diem and lodging allowances. Carla will try to get information to Paul. U of I will reach out to the other Big 10 schools to see what they follow. Susie will share information she has already received from employees.
  - b. Carla asked if COVID vaccine for overseas travel is required or reimbursed. What about mandated vaccines? Susie advised that U of I will reimburse for required and suggested vaccines.
  - c. Tracy Rembusch asked if anyone allowed business class on Amtrak. The board advised business class may be allowed for extenuating circumstances.
  - d. Debbie Bonnell asked if institutions are paying the IRS mileage per diem for electric vehicles. EIU and U of I advised they are since buying an electric vehicle is an employee's choice. Paul shared that EIU uses the most economical cost method for reimbursement. If using a vehicle, EIU reimburses based upon the mileage. The allocation of those costs depending on the vehicle may be different—the cost of gasoline vs electricity, license and the amount of depreciation, but they still pay by the mile.

Paul asked if anyone had anything else to discuss and received no response.
