- a. JCAR updates
 - i. The January 16 meeting postponed the review of the rules until early February but the new statute for meal per diem, lodging, and mileage was effective January 1, 2024 so institutions may implement. Jessica asked if everyone is only reimbursing meals and not incidentals. Carla advised ISU is only reimbursing meals. Aaron advised that lunch is still not reimbursed for travel less than 18 hours (same day). Other schools stated the same. U of I is staying with quarter system for meal reimbursement as that did not change.
- b. Jessica asked if anyone has employees stay on campus, their designated headquarters, and allow it. Carla advised yes when required by job responsibilities, event requirements, etc. U of I is the same.

Aaron asked if anyone had questions or other business to discuss. Hearing none, he advised the next meeting is scheduled for Wednesday, April 24, 2024, at 9:30am.
