- Maxine Sandretto presented for discussion making changes to the code to allow teleconferencing vs. videoconferencing. It was noted by the members that the change was made from teleconferencing to videoconferencing due to language in the Open Meetings Act (5 ILCS 120).
- Peggy Podlasek asked if the HETCB would follow the Governor's Travel Control Board Travel Update 11-02 regarding lodging rates in Chicago. After discussion, the HETCB moved not to adopt this change. A motion was made by Peggy Podlasek and seconded by Bruce Bennett. Motion approved.
